- 4. Brantham Athletic request Terms of Contract Change Ther terms of the contract had been changed to include parking on west side of School Field limit of 30 -/No parking in Case car park/trial period July-September £80 per month and responsibility for ensuring the entrance to the School field is secured after use An e-mail has been received from Brantham Athletic saying the facility is fantastic and they plan to use it until late September when the light allows. They also expressed interest in using the facility again next year from April to September and asked for this to be considered. Councillors agreed to continued use until end of September and for Brantham Athletic to cancel the Portaloo from the end of September. It was also proposed that we offer the use of the field under similar terms to Brantham Athletic next year. We need list of key holders keys to be returned by Brantham Athletic at end of September

Once the changes have been made the Clerk will send to school so they can be put on the Notice Board.

6 Case Lane – Playing Field Entrance – To agree quotes – Two quotes had been received from A W Goddard Fencing 7129 – to set Gate further back and rehang existing single field gate £1,560 and 7128 Repair existing fencing with new gate £1590 – after some discussion it was proposed to accept 7129 at a cost of £1,560.

7. <u>Any Other Business</u> Resident asked if church banner could be put on the Playing Field fence – it's usually there for one week. Every four months. Councillors agreed that it could be affixed to the fence.
